Affiant objects and rebukes Respondent's claims to label Affiant as a Communist. Affiant has no political ties with the Communist Party, Evidenced within Exhibit 2 in this Affidavit of Fact, and

Respondent Allan Clinton Poe incited, assisted, and engaged in treasonous acts of open resistance with and for the Continental Army coup against the Government of The United States of America while presenting a false pretense as Chapter 41 State of South Carolina State Coordinator for the NANP, Evidenced within Exhibit 9 in this Affidavit of Fact, and

5. On the 190th Day in the Year of Yahweh 6024, translated the 25th day of September in the two thousand and twenty-second year of the new covenant in Yahushua's name, Respondent Michael Paul Scott, was noticed via the Telegram app at 9:35 PM UTC-6 by Affiant that "The American National Flag Ordering Group has been hijacked. are advised to leave the group and a new venue for flag ordering will be established and notified in Free Trade." Respondent Michael Paul Scott became belligerent and asked Affiant to see proof of notice. Affiant provided Respondent Michael Paul Scott with JPEG file of a conspiracy pyramid chart created by Respondent Sheilla Rae Van Dusseldorp who hijacked The American National Flag Ordering Group on the Telegram app. Respondent Michael Paul Scott was made aware that per Post Master General, hereinafter 'PMG,' "IT IS ORDERED, that SHEILLA RAE VAN DUSSELDORP, PMA and SHEILLA RAE VAN DUSSELDORP as it pertains to the delivery of her person is hereby cancelled and returned to the offshore trust that it came from and wherein it shall remain for the rest of SHEILLA RAE VAN DUSSELDORP'S natural life," Evidenced in Exhibit 5 within this Affidavit of Fact, and

Respondent Michael Paul Scott proceeded to associate a false resignation with the removal as State Coordinator, Evidenced in Exhibit 5 within this Affidavit of Fact, and

Respondent Rebecca Ann Brown has since continued to exploit personal issues and refuses to consider the facts of those personal issues, shifting blame to others as opposed to accepting responsibility of said abuse. This is persecution of beliefs and Human Rights Violations, violating Articles 1, 2, 7, 12, 18, 19, 28, and 30 of Public Laws 101, Evidenced in Exhibit 7 within this Affidavit of Fact, and

On the same Day, Affiant was eyewitness to Respondent Erika Marie Scott verbally being asked about the mentioning of her name simultaneously with Respondent Sheilla Rae Van Dusseldorp by PMG on the Temple Telegram group. Respondent Erika Marie Scott denied any involvement with Respondent Sheilla Rae Van Dusseldorp. Following the post of the CDP, International, National, and County Notices were published in both The Revolutionary Times News evidenced in Link 1 and the American Herald News evidenced in Link 2 wherein the CDP was provided within the publications, and

TOBY impelled hatred that can result in killing innocent people, including Affiant. The false claims made by TOBY places limitations of the freedoms afforded to Affiant which take the form of hate crimes, violating Articles 1, 3, 5, 7, 12, 28, 30 of Public Laws 101, Evidenced within Exhibit 8 in this Affidavit of Fact, and

On the same Day, Affiant discovered that Respondent Robert Mark Roache incited, assisted, and engaged in treasonous acts of open resistance with and for the Continental Army coup against the Government of The United States of America by providing access to Respondent Jay Von Spreck and hijacking the American National assembly, hereinafter 'ANa,' website while presenting a false pretense as Appointed Secretary of the ANa and Chapter 39 State of Pennsylvania State Coordinator for the NANP, Evidenced within Link 5 in this Affidavit of Fact, and
