As Continental Army members we must hold our self to the highest professional standards, and we must prosecute communism with extreme prejudice. **Any Continental Army member or government official found guilty of communism, espionage, treason, and war crimes will be put to death!***

2. The aforementioned Statement in point 1 by Respondent Jay Von Spreck was posted in a public forum visible to Affiant and other General Post Master(s) hereinafter “GPM”(s). Meanwhile in a private Telegram chat titled ‘Continental Army 1775’ the Respondents were conspiring back and forth. After Reading the Continental Army 1775 Telegram chat dated Between (September 19th 2022 and October 2nd 2022) there is an Obvious group effort to label all GMPs as communists. A Statement by Respondent Allen Clinton Poe was as follows....” GPMs express complete and perfect supremacy over persons. What they say becomes law, they are the communists” according to Respondents Jay Von Spreck, and

3. On the 197th Day in the Year of Yahweh 6024, translated the 2nd day of October in the two thousand and twenty-second year of the new covenant in Yahushua’s name, the Secretary of State for The United States of America hereinafter “SoS” posted in the General Post Office Telegram app group hereinafter “GPO group” the following verbiage: “We have people that are trying to overthrow the Government again. There are people conspiring. Take this under advisement”, and

4. At approximately 4:40 PM UTC-4 the same day the Post Master General of The United States of America hereinafter “PMG” posted in the GPO group a Cancellation of Delivery of Persons pdf evidenced in Exhibit 1 wherein the delivery of Respondents PERSONS were cancelled and returned to the offshore trust to remain for life and all records and evidence of Respondents PERSONS would be removed from the archives. The said pdf acknowledged should any of the Respondents have a claim it may be addressed to the Human Rights Tribunal International of The United States of America hereinafter “HRTI”, and

5. Following the post of the Cancellation of Delivery of Persons hereinafter “CDP”, International, National, and County Notices were published in both The Revolutionary Times News evidenced in **Link 1** and the American Herald News evidenced in **Link 2** wherein the CDP was provided within the publications, and

6. With the seriousness of nefarious actions by Respondents up to the 198th Day in the Year of Yahweh 6024, translated the 3rd day of October in the two thousand and twenty-second year of the new covenant in Yahushua’s name, numerous General Post Masters for the Government of The United States of America including Affiant gathered in assembly to witness a video recording providing evidence of Respondents nefarious actions regarding the Continental Army, one of the Military Branches for The United States of America among other nefarious actions by Respondents evidenced in **Link 3**, and

7. Respondents have collectively associated in consenting to an arbitrary death sentence upon all General Post Masters as members of the National assembly for the Government of The United States of America as evidenced in Link 1, Link 2, and Link 3 resulting in all General Post Masters including Affiant to remain armed and on high alert for the following Six (6) months, and

8. Respondent Kaleb A Kensmoe a member of the American National Union assembly hereinafter “ANU”, subverted a telegram group designed to encourage membership to the ANU that was subsequently absorbed by the General Post Union. This was by removing administrator privileges for those pursuing this purpose, affiant included, and adding privileges to those who were cooperating to pursue a course of treason evidenced in **LINK 4**, and

9. Affiant agrees to the submission of this Affidavit of Fact for any and all charges brought forward as agreed upon by the Great Jury for the General Post Union of The United States of America to be submitted to one of the Tribunals of and for The United States of America for remedy sought, and

The Respondents shall have Ten (10) days from the international, National, and county publication to give rebuttal to the claims stated within this Affidavit or these claims shall further stand as fact.

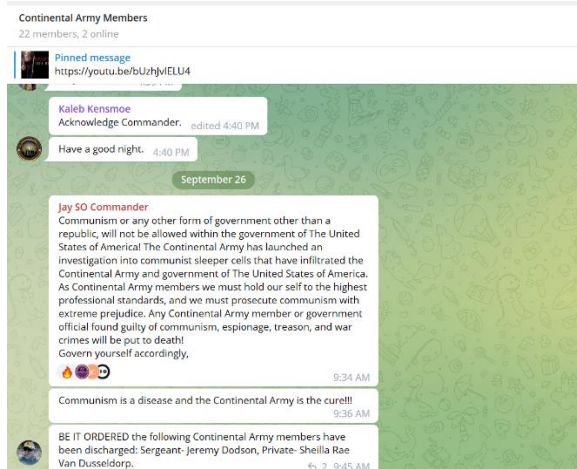

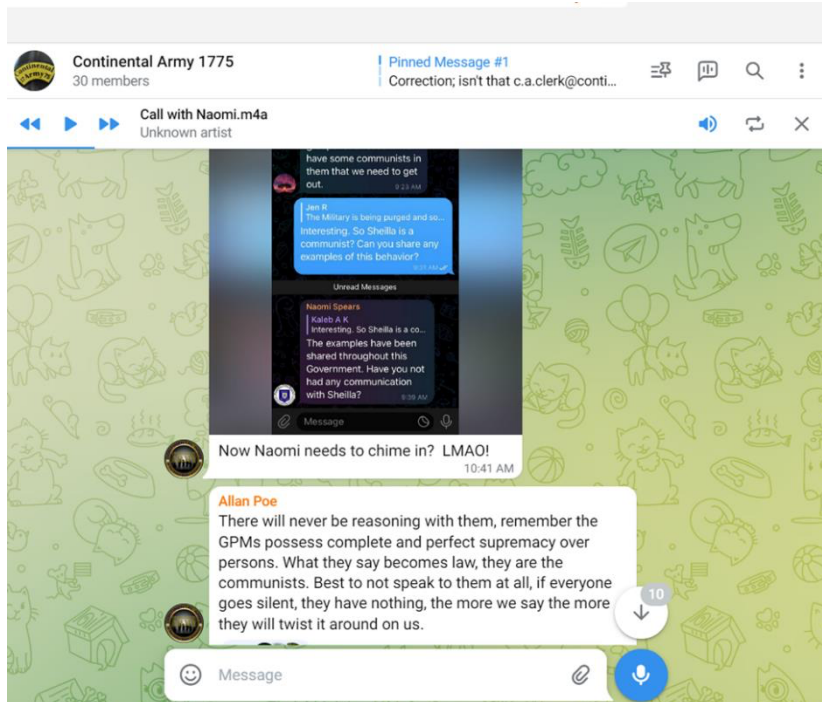
