## EXECUTIVE PROCLAMATION-Q0006

By the Executive power vested in office of president for The United States of America by the National assembly for the Government of The United States of America, the following is an executive proclamation:

### PROCLAMATION OF FORCED DEPORTATION AND PRIVATE LAND PROPERTY NATIONALIZATION

WHEREAS, the members of The Satanic Temple hereinafter, "TST", have violated international Law, the codified *Law of Nations Book I Chapter XII Of Piety and Religion § 131*. When there is an *established religion* wherein it states;

*"When the choice of a religion is already made, and there is one established by law, the nation ought to protect and support that religion, and preserve it as an establishment of the greatest importance, without, however, blindly rejecting the changes that may be proposed to render it more pure and useful: for we ought, in all things, to aim at perfection", and*

WHEREAS, the members of TST have violated the established public religion within the States of the Union of The United States of America as published within Article 3 of the Bi-Lateral Social Compact Agreement by and between the people for The United States of America [LINK](#), and



WHEREAS, the members of TST have been participating in the New World Order social compact Articles 1 and 2 of the Georgia Guide Stones evidenced herein [LINK](#), and

WHEREAS, the members of TST have been notified of forced deportation in accordance with the Forced Deportation Act of 2021 [LINK](#) issued by the National assembly for the Government of The United States of America, and

WHEREAS, Haverhill Elementary School hereinafter, “HES”, located at (4725 Weatherside Run Fort Wayne, IN 46804), within the Southwest Allen County School District hereinafter, “SACSD”, for the corporate subdivision of Indiana is allowing Jessica Klikas hereinafter, “Klikas”, a member and owner of The Satanic Temple Indiana hereinafter, “TSTI”, to continue employment as an instructional teacher for fourth grade students in violation of the Forced Deportation Act of 2021 issued for Klikas [LINK](#), and

WHEREAS, in accordance with the terms of the Notice of Forced Deportation, those persons aiding and abetting in associating with the members of TST shall be subject to forced deportation and the nationalization of those persons private land properties, and

WHEREAS, the HES’s Principal Ashley Ransom [LINK](#) and the Human Resources Director for SACSD’s LuAnn Erickson [LINK](#) are responsible for the continued employment of Klikas at HES, and

NOW BE IT ORDERED, the National assembly for the Government of The United States of America hereby notices Ashley Ransom, LuAnn Erickson, Jessica Klikas **and family hereinafter collectively, “Respondents”**, of Respondents forced deportation in accordance with the Forced Deportation Act of 2021 for aiding and abetting in the association with the members of TST, ordered to vacate the metes and bounds and seaward boundaries of The United States of America, and

BE IT ORDERED, Respondents are hereby noticed of the nationalization of Respondent’s private land properties within the metes and bounds and seaward boundaries of The United States of America as follows;

1. **The private land property of Ashley Ransom and family located at 6310 Eagle Nest Ct. Fort Wayne, IN 46814.**
2. **The private land property of LuAnn Erickson and family located at 11530 Tillbury Cv. Fort Wayne, IN 46845.**
3. **The private land property of Jessica Klikas and family located at 4517 Leeward Cv. Fort Wayne, IN 46804.**

**This Proclamation of Deportation and Property Nationalization shall serve as proper and legal notification for Respondents ordered this 304th Day in the year of Yahweh 6023, translated the**



24th day of January in the two thousand and twenty-second year of the new covenant in Yahushua's name.
